3. Minutes from the previous Annual General Meeting

There were no matters arising from the previous AGM.

Motion 1:

4. New Business

a). Presentation of 2019 Annual Report

The 2019 Annual Report was presented at the meeting. Key areas highlighted :

Representative report as Tabled.

Continous growth in the NSBHA rep program since the first season in 2015 as NSB. All 2019 teams and participants represented NSBHA with pride. NSBHA rep program supported by 52 volunteers in 2019 assisting with coaching, managing, selecting and organisation. All these people to be acknowledged for their effort and significant contributions to NSBHA. Opens Men's rep team filled by players from Manly, UTS and GNS – positive to see this collaboration. Other initiatives for 2019 (such as specialiast goal keeping training, U11 academy training) received well.



Indoor hockey growing subtantially. Acknowledged significant contribution by Mark Hewitt-Park.

Treaurer's Report as tabled.

Key issue raised was the cost of the growing Representative program and that overall it made a loss of \$14k for the year ended 30 Sept 2019 (after adjusting for the upfront payment made to Marie Bashir indoor centre for the 19/20 summer indoor program).

Whilst overall the competitions made a small profit, the rep program is loss making due to the current cap placed on the players' fees and rising accommodation and comp costs.

Questions raised as to the sustainability of this loss, to what extent does the association subsidise the rep program and where can costs be trimmed.

It was agreed that the new rep committee need to address this issue and provide a recommendation for the executive committee to approve.

The treasurer provided the breakdown of the profit / loss for each of the Competitions as follows:

Mollie Dive (\$224.00) HBC 5 aside (\$2,835.47) KHC 6 aside \$1,895.00 KHC Train & Play \$3,483.83 Consolidated Competition Profit \$2,319.36

Whilst overall the Competitions made a profit, discussion took place on the reasons some were loss making and possible options to prevent this in the future. The Treasurer and Competitions Convenor will work together on the budgeting process for 2020 to ensure the competition fee income covers costs.

Masters report as Tabled.

Acknowledged the work of Kim Dunkin and masters committee. NSBHA Masters rep program has grown continuously since amalgamtion with WHA and sees great collaboration across NSB clubs with inclusion of players from Manly, Avalon and Seaforth.

Competitions report as Tabled.

New initiatives such as Train and Play received very well by participants. Offering Term by Term products works better than full season. Small sided games provide huge opportunity for player and umpire development. NSBHA develop Competitions program for 2020 and publish this to the hockey community in early 2020.

Facilities report as Tabled.

Recent developments include prospect for synthetic surface at North Manly Bowling Club which has remained idle since August 2018. Northern Beaches Facilities Committee (Jeremy Boyse and members from WHA) are currently completing a submission for single hockey pitch to the Northern Beaches Council. Submission due Thursday 28 November 2019.

That the 2019 Annual Report be accepted as tabled and posted on the Association website.

2020 Facilities Convenor

Jeremy Boyse is continuing in this role as Facilities Convenor

2020 Competitions Convenor

Cath Clarke is continuing in this role as Competitions Convenor

Nomination received by Suzi Litchfield. Seconded by: Christine Cannon Outcome: There being no other nominations, Suzi Litchfield was elected as General Committee Member.

2020 General Committee Member

Nomination received by Karen Champion. Seconded by: Becky Bland Outcome: There being no other nominations, Karen Champion was elected as General Committee Member.



c). 2020 membership registration and fees

It was acknowledged that NSBHA will be charging GST for the financial year beginning 1 October 2019 and accordingly all fees (NSBHA membership fee, competitions etc) need to increase by the 10% GST.

Discussion followed on merits or otherwise of increasing the membership fee, given the fee has remained the same since the Association commenced in November 2014. Securing funds from the membership base for future facilities also considered. It was generally agreed to keep the junior fees the same, but to increase the over 18 rate to a total fee of \$50 (inclusive of GST).

Social media /communications across NSBHA clubs. Social media policy required. Committee to examine.

POST AGM EVENT

The operators of Ku-ring-gai Hockey Centre, KHC Inc, and Harbord Bowling Club issued several invoices for Turf/field hire in late November 2019.

These invoices related to turf/field hire for the NSBHA competitions during the period May 2019 to September 2019 and amounted to \$7,205.00.

For accuracy in reporting on each of the NSBHA divisions it was agreed by the Executive Committee on 2nd December 2019 to adopt an accrual basis of accounting (rather than the previously used cash basis of accounting) and accordingly adjust the Annual Accounts for 30 September 2019 and include these field hire invoices. These are shown as Accrued Expenses of \$7,205.00 on the Balance Sheet.

After other accrual adjustments to remove expenses that related to the prior year, the Association made an overall profit of \$22,296 instead of the previously reported profit of \$18,544. The breakdown of the gross and net profit is shown below:
